## 4. PROPOSAL ACTION:

KNR HEALTH AND HUMAN PERFORMANCE SEQUENCE (New) Fillman and Lippert ALLIED HEALTH PROFESSIONS SEQUENCE (New) MINOR IN EXERCISE SCIENCE (Revise)

There were minor edits requested for the Allied Health Professions Sequence at the last meeting and the changes were done. With no further discussion needed, Fillman moved to approve the two new sequences, Laudicina seconded, and the committee approved by acclamation. ## Program Admission Requirements for New and Continuing Students:

Admission to this academic program is limited and is based on space availability and the competitiveness of the applicant pool. Health and Human Performance Program of Study:

- 55 total hours are required.
- 19 hours in core courses: KNR 164, 181, 182, 183, 257, 280, *282.
- 24 hours in major courses: KNR 240, 254, 298A10, 303, 307, 309, 311, 313, and one of KNR 286, 305,310 , or 353.
- 12 hours from either of the following options: Option 1: KNR 378A10 and 10 hours in KNR 398A11. Option 2 (requires program approval): 12 hours of advanced studies from courses approved by exercise science faculty.
*NOTE: KNR 282 requires PHY 105 or 108, which can be used for General Education NSA credit.

Standards for Progress in the Major:

Once admitted to either sequence within the Exercise Science major, the student must maintain a minimum 2.50 cumulative GPA. A student falling below the required 2.50 GPA will be placed on probation for one semester. If after one semester the 2.50 GPA has not been re-established, the student will be dropped from the Exercise Science major. A student who has been thus dropped from the Exercise Science major may reapply for admission to the major after raising his or her GPA to the required standard. The student who is not readmitted after one semester of probation and has a minimum 2.00 GPA will have the option of entering the Kinesiology Studies Sequence. A student must have a minimum 2.50 cumulative GPA and have completed all major courses with a grade of C or better to participate in the senior internship (KNR 398A11 Professional Practice: Internship in Exercise Science). Students seeking to take Option 2 (12 hours of advanced coursework in lieu of KNR 378A10 and KNR 398A11) must apply for approval of this option at the start of the semester in which they are registered to take KNR 298A10. The application must include a statement as to why the review committee should allow the student entry into this option, and it must also speak to what steps the student has taken to prepare for academic study beyond the B.S. in Exercise Science. Examples of such preparation might include indications of pre-requisites completed, observation hours completed, completion of research statistics or methods courses, applications to graduate or professional schools, etc. Applications for this option will be considered by a committee of Exercise Science faculty.

Credentialing Opportunities:
There is no single professional credential or certification that is necessary to pursue a career in Exercise Science. However, there are a number of optional credentialing opportunities that students are encouraged to examine. Coursework in this major is focused on the content areas needed for certification preparation by several organizations in this professional field of study. Students who are not granted consent may be advised to retake MUS 205A01 and request consent again.

- 9 hours chosen from ATK 240, 340, 345, and 380 or other ATK courses with consent from Music Theory Coordinator.
-3 hours of MUS 122 and demonstrate Level III Piano Proficiency.

Of the 12 hours, at least 2 hours ( 1 semester) must be at the 200 -level. NOTE: For voice students, successful completion of MUS 127 is highly recommended before signing up for the 200-level jury.
-A grade of $\mathbf{C}$ or better is required in all courses in the major including specific requirements for this sequence.

- 14 hours ( 7 semesters) of Applied Music on the major instrument from MUS 131, 132, 133, 134, 135, 136, 137, 138, 231, 232, 233, 234, 235, 236, 237, or 238 . Of the 14 hours at least 2 hours ( 1 semester) must be at the 200-level. NOTE: For voice students, successful completion of MUS 127 is highly recommended before signing up for the $\mathbf{2 0 0}$-level jury.
*Level IV piano proficiency is required for this sequence.

Ethnic Studies is the study of race and ethnicity in U.S. and transnational contexts. Students and faculty in this area examine how social categories like race, indigeneity, culture, ethnicity, and nation are conceptualized. They also familiarize themselves with the specific and comparative experiences both historical and contemporary of the major population groups that make up the United States. The program at Illinois State allows participants to examine regional, national, and global dimensions of these experiences.

Students in the minor must complete a minimum of 22 hours representing 8 courses as indicated from Groups I, II, and III; at least 4 courses must be above the $100-l e v e l$. With consent of the director, students may use departmental or IDS 287, 298, or 398 courses for one course in Group II and/or one course in Group III.

Students interested in pursuing a major in this area may arrange their program of study through either the Interdisciplinary Studies Major program or the University Studies program.

Minors are also available in three specific areas: African-American Studies; Latin American and Latino/a Studies; and Native American Studies.

## 5. PROPOSAL DISCUSSION:

IDS MINOR IN ETHNIC STUDIES (Revised)
Wolstein and Wolf
Wolf distributed a handout and presented a review of the proposal to review the minor.

- Several courses were deleted because they are no longer in the catalog: ECO 230, HIS 269, MUS 216, and NUR 312.
- It was noted that the initiator said that ENG/LAN 206 will likely be decimalized in upcoming catalogs. If that change coincides with this proposal, they asked if the decimalized instances of the course could also be included in the same Group. Ryburn said that nothing has been submitted to decimalize these courses.
- Several courses were added: to Group II electives: ANT 351, EAF 228, 231, 235, FCS 252, GEO 306A22, HIS 328, PSY 327A01, 327A02, TCH 207, and to Group III: ANT 303, ART 303, CJS 306, 369, COM 320A01, 390A01, FCS 222, GEO 142, 306A26, HIS 336, 370, MUS 356A01, THE 271A07 and 375.
- Department chairs/school directors were contacted to confirm their agreement to add the courses to the minor. Ryburn confirmed that the emails of concurrence have been received.
Comments/Questions:
- Zeng was recently invited to be a co-director of the Minor in Ethnic Studies.
- It was noted that the correct abbreviation for Theatre courses is THE, not THD. Ryburn will edit the proposal's catalog copy.

With nothing further to discuss, Trefzger moved to suspend the practice of "discussion one week, action the next," and vote on the proposal today; Cook seconded, and the committee approved by acclamation. (See "Proposal Action" above.)

## IDS MINOR IN FOOD STUDIES (New)

Gina Hunter and Ryan Gray were present from the Department of Sociology and Anthropology. Dustin distributed a handout and presented a review of the proposal for the new IDS Minor in Food Studies. Dustin invited Hunter to explain the new minor.

- Hunter said that there are faculty on campus who are engaged in food-related research.
- Faculty involved in the minor met with community partners who might serve as professional practice partners for the minor.
- The minor draws on courses from nine programs across campus. Because of the diversity of the courses offered, they do not expect much impact on any one course or program.
- The list of courses was developed in consultation with faculty and advisors at a March 2018 campus meeting and via email discussions. All department chairpersons, with courses in the minor, have given their written consent.
Comments/Questions:
- Standard noted that two new courses were created for the minor: ANT 105 and 343. ANT 105 was approved for General Education credit.
- Laudicina asked who would supervise the 398 Professional Practice courses. Hunter replied that Anthropology would supervise.
- There were a few editorial corrections that needed to be made.

With nothing further to discuss, Trefzger moved to suspend the practice of "discussion one week, action the next," and vote on the proposal today, Cook seconded, and the committee approved by acclamation. (See "Proposal Action" above.)

## 6. LIAISON REPORTS:

a. Council on General Education - Standard indicated that CGE did not meet, so there was nothing to report.
b. Council for Teacher Education - Mikulec was absent. Rosenthal reported that the CTE continued to discuss the online portfolio requirement and the national background check. Also, the proposal for SED 344 is still pending.
c. Academic Affairs Committee - Trefzger stated that there was no meeting last week, so there is nothing to report. He will attend tonight's meeting.

## 7. STAFF REPORT:

Ryburn: There is one proposal ready for review at the next meeting.
Rosenthal: We are still waiting on approval from all the Colleges of the proposal for the new Repeat Policy and for Danielle Lindsey's request for catalog reformatting.

## 8. MISCELLANEOUS:

Standard: FRE/POR/SPA 116 \& SPA 120/AMALI Proposal. We have received the revised syllabi and course descriptions. Ryburn will send the syllabi to members to review for discussion at the meeting in two weeks.

Standard: Curriculum Forms Revision. Standard said the memo is ready to send out to the University regarding the change on the Revise Program curriculum form to have two questions about letters of concurrence: one for added courses and one for notification of courses being removed. She handed out a draft of the memo. The committee consented to sending out the memo as follows:

The University Curriculum Committee (UCC) was asked recently to review its procedures for requests regarding additions or deletions of courses from different departments/schools in curriculum proposals for revisions of majors, sequences, and minors.

The UCC discussed this issue at its October 3, 2018 meeting and confirmed the following procedures:
(1) For departments/schools revising a program (including a major, sequence, or minor) in which a course from another department/school is being added as a required or elective course, the department/school must obtain a letter of concurrence from each department/school impacted by this addition. A letter of concurrence from each affected department/school must be uploaded to the Curriculum Forms system.
(2) For departments/schools revising a program (including a major, sequence, or minor) in which a course from another department/school is being deleted as a required or elective course, the department/school must notify each department/school impacted by such a deletion. This notification must be indicated in the Curriculum Forms system.

The UCC notes, however, that the instructions in the Curriculum Forms system (https://registrar.illinoisstate.edu/curriculumforms) currently appear somewhat ambiguous regarding these procedures. Therefore, UCC has requested changes to the online Curriculum Forms system, and these changes have now been implemented.
The previous portion of the Curriculum Forms system for revised program proposals includes the following question:

Have letter(s) of concurrence from affected departments/schools been obtained? (Y/N)
A departments/school is affected if it has a program with significant overlap or if it teaches a required or elective course in the program.

The updated section splits this question into two parts as indicated:
If this program revision includes addition of one or more required or elective courses from another department/school, or if it has significant overlap with another program, a letter of concurrence from each affected department/school is required.
9. ADJOURNED: Dustin moved to adjourn, Cook seconded. The meeting adjourned at $4: 15$ p.m. The next meeting will be on November 7, 2018.
