## c. SED - Specialist in Low Vision and Blindness (Revision) - Hughes & Allbaugh

Hughes moved to approve the proposal to move TCH 208 from the core courses required for the major and replace it with SED 342; TCH 208 is changed to a requirement for the sequence in Low Vision and Blindness. Allbaugh seconded. The committee approved by acclamation.

d. SED - Specialist in Deaf and Hard of Hearing (Revision) - Lippert & Duce

Duce asked if it was okay that the plan of study included summer classes. Standard indicated that it was and that some programs do include summer courses in their suggested plans of study, especially teacher education. Lippert moved to approve the proposal to remove TCH 208, CSD 249, and 350 from the major/sequence and to add CSD 212 to the major/sequence and to reduce the total hours by 2 to 86. Duce seconded. The committee approved by acclamation.

## e. <u>SED – Specialist in Learning and Behavior</u> (Revision) – Savage & Dustin

Savage moved to approve the proposal to shift TCH 208 from the core courses required for the major and replace it with SED 342; TCH 208 is changed to a requirement for the sequence for the Specialist in Learning and Behavior. Dustin seconded. The committee approved by acclamation.

No change in catalog copy is necessary for the new 2019-2020 format.

## 5. PROPOSAL DISCUSSION:

a. IDS - Minor in Entrepreneurship (New) - Zeng, Trefzger

Mark Hoelscher (MQM) and Laurie Merriman (THD) were present for the discussion. Zeng provided an overview of the proposal and stated that the new Minor in Entrepreneurship will be open to all students. The required courses are already offered once a year.

Trefzger wondered whether any E-contract courses already exist. Ray noted that E-contract courses do not exist outside of the Honors Program. These type of courses would be independent studies. The proposers will work with Lindsey to amend the catalog copy to make the wording about the E-contracts similar to that for similar experiences in other programs for consistency.

Lindsey stated that contact information for the minor is required for the catalog copy. A contact person needs to be identified so they can be given permission to submit exceptions for students in the system (for the 9 hours of electives). Hurd pointed out that the title is "Minor in Campus-Wide Entrepreneurship" in some places on the proposal and "Minor in Entrepreneurship" in others. Merriman suggested that the preferred name is "Minor in Entrepreneurship".

Lippert wondered whether there were any concerns related to resources to offer the courses. Hoelscher stated that the College of Business is very committed to this minor and is supportive. Merriman added that if more sections are needed in the future, she expected that the two Deans (COB and CFA) would meet to discuss.

Zeng asked about the prerequisites for MQM 328 and whether or not it would be the last course that students take in the minor. Hoelscher said that it was and that he would be fine with the addition of MQM 128 as a prerequisite to MQM 328.

Lindsey noted that the proposers would be able to submit a course revision proposal (for MQM 328) and make the edits in wording for the Minor proposal in the Curriculum Forms systems.

# b. THD - Minor in Film Studies (Revision) - Dustin & Lippert

Dustin indicated that the only change in the proposed revision to the minor is to include COM/THE 306 as an elective option. Zeng (the proposal initiator) pointed out that THE does not offer production courses so they needed to partner with COM. Accreditation issues require the course to be cross-listed.

c. THD – <u>Theatre and Film Studies Sequence</u> (Revision) – Pence & Mikulec
 Pence noted that the revision involves the addition of COM/THE 306 to the sequence as part of the electives. No other changes are involved.

# 6. LIAISON REPORTS:

- a. Council on General Education Standard Nothing to report as CGE has not met since the last UCC meeting.
- b. Council for Teacher Education Mikulec (not in attendance)
  Hurd noted that two proposals for revised programs will be coming to UCC soon: the Theatre Teacher Education sequence and the Business Teacher Education sequence. Both revisions involve EAF or TCH course deletions and addition of SED 344.
- c. Academic Affairs Committee Trefzger The AAC has not met since the last UCC meeting. Ray asked if the Repeat Policy had been discussed. Hurd indicated that she would check on it.

# 7. STAFF REPORT:

Hurd: Minor revisions have been received related to the IDEAS objectives. They have been sent to Rocio Rivadeneyra, Honors Program Director and former Chair of the Ad Hoc Committee, to review. Once she has done so, Hurd will provide the UCC members with an update.

## 8. MISCELLANEOUS:

Standard: Dr. Kalter indicated that the AMALI faculty group reviewed the request to accept SPA/FRE/POR 116 and SPA 120 for AMALI credit and after spring break the UCC will discuss their feedback.
