1. Convene: Califf convened September 16, 2020 UCC Meeting

#### 2. Introductions:

**3. Approval of Minutes:** Califf asked the UCC members if any changes/edits should be submitted. Hearing none, the minutes were approved.

### 4. Proposed Discussion and Action:

### a. Water Sustainability Minor (IDS) - Carlson, Newport

Carlson explained that this program is an IDS program and how it involves multiple departments. Carlson indicated that the letters of support shows the support from the different departments. Carlson explained the relatively straightforward program as only requiring one course and then students have a selection of different electives. Carlson indicated that the prerequisites of the electives were not an issue/conflictual to the program. Lindsey (guest) clarified the required course and how it is crosslisted. Brehm (guest) answered in the affirmative. A general discussion occurred about this course and it was concluded that Gawron (guest) would edit the proposal to change how it is reflected on the proposal. Howell asked about the proposal being an IDS course, but not listing any IDS courses as electives/required. Brehm answered that this was intentional to foster a more inclusive interdisciplinary experience. Califf asked if there were any more questions. Gawron (guest) indicated that this could be a good example of, if the UCC wanted to vote for approval pending editorial changes, they could. Newport motioned a vote. Carlson seconded. All voted in favor. Brehm thanked everyone of the UCC. Below is the approved catalog copy:

# b. AMD History General Sequence (HIS) – Howell, Paolucci

Paolucci/Howell indicated the general editorial concerns that appeared last week with the proposal and explained the editorial process that it went through from last week. Overall, they indicated nothing was wrong with the content of the proposal last week but the proposal needed substantial editorial revision for clarity purposes. Lindsey (guest) highlighted the importance of clear catalog copy both as a communication tool for students/staff/faculty, but also for degree audit construction. Howell indicated that 497 was clarified to be a part of the 12 graduate credit hours a student can take. Paolucci reiterated the editorial process and the amount of work that went into addressing the concerns. Califf agreed with Paolucci. Howell motioned a vote. Paolucci seconded. All voted in favor. For History (B.A.) – Students are encouraged to complete a minor, but, if a minor is not selected, they must complete a 9-hour concentration in any field other than History or a Foreign Language, with at least three credit hours at the senior college level.

For History (B.S.) – Major requirements are the same as for the B.A. except students must complete a minor.

\* It is encouraged for students to take courses approved for graduate credit. For 300-level and 400-level courses approved for graduate credit see courses listed with (GRAD) at https://coursefinder.illinoisstate.edu/directory/his/

This sequence allows students to take up to 12 hours of approved graduate courses that will count for both the undergraduate and graduate program in History. In addition to the HIS 497 required course, students may choose to take up to 9 hours of graduate level electives to count towards the 9 credit hours of additional senior college level History electives required for the undergraduate program. # c. AMD History Social Science Teacher Ed (HIS) – Howell, Paolucci

Howell indicated that this proposal suffered from the same editorial unclarity that AMD General History suffered from. However, through the editorial and collaborative process, these concerns were allayed. Howell motioned a vote. Paolucci seconded. All voted in favor. Below is the approved catalog copy:

Accelerated Master's Degree Sequence for History Social Sciences Teacher Education. BA/BS

High achieving students with a cumulative GPA of 3.20 or higher and a GPA of 3.5 or higher in the major may apply to the accelerated sequence one year before completion of their undergraduate degree. This sequence allows students to take up to 12 hours of approved graduate courses that will count for both the undergraduate and graduate program in History. Students can then apply to the History graduate program in the spring of their senior year. Enrollment in the Accelerated Sequence does not guarantee final admission into History graduate program. For additional information on minimum requirements for admission and the application and selection process, visit IllinoisState.edu/Majors and the History Department advisor.

HIS 100 is limited to First-Semester Freshmen. Transfer students from outside ISU or from a different major at ISU will need to see the advisor.

The Teacher Education Sequence is part of the entitlement program leading to secondary History-Social Sciences licensure.

A minimum 2.75 GPA in the major and overall is required for admission to Professional Studies. A minimum 3.00 GPA is required for Admission to Student Teaching. Deadlines for admission to Professional Studies and Student Teaching are available from the Cecelia J. Lauby Center for Teacher Education.

After completing student teaching and undergraduate degree in their ninth semester, students would graduate with a Master's degree with an additional year of enrollment.

# d. Major in Music Education (4 sequences) (MUS) - Carlson, Newport

Newport explained the changes in the proposal and indicated it was straightforward. The total hours were not changing, and the only change was switch SED 344 from required to a "Take 1 of the following" option with MUS 371. Newport asked if this change was fine and if the letter, they attached was enough. Gawron (guest) indicated that was the case given that they were not eliminating the course but giving their students options. Kroesch asked why SED 344 was being switched to an option. Lindsey (guest) referenced the rationale of the proposal and how they hope to offer a course similar to SED 344, but specific to music. Hurd explained the general history of SED 344. Califf clarified that this option was primarily between a general special education course and a major-specific special education course. Gawron clarified that this change is affecting four sequences, but because this change is the same uniform change without total hours changing, one proposal was sufficient. Newport motioned a vote. Carlson seconded. 9 voted in favor and Kroesch abstained. Kroesch stated she joined the Zoom late and was not present at the previous discussions. Below is the approved catalog copy:

# 5. Liaison Assignments:

### a. Council of General Education:

Nothing reported

### b. Council for Teacher Education:

Hurd – indicated that CTE was a short meeting and nothing particularly difficult was reviewed/on the agenda. Nothing related to UCC was discussed/approved

### c. Academic Affairs Committee:

Paolucci indicated he missed the meeting due to illness. Hurd indicated she was present at the meeting. Hurd explained that IDEAS was being discussed and how IDEAS relates to graduate requirements. It was generally discussed that IDEAS is similar to AMALI, but AMALI being a general education requirement, while IDEAS being a graduate requirement. Lindsey (guest) asked if it affected all students. Hurd indicated that it is/was meant to be geared more towards native students (non-transfer students).

### 6. Staff Report:

Hurd indicated that the general education revision taskforce is meeting soon this fall.

### 7. Miscellaneous:

Califf asked Kroesch about being a CTE liaison for UCC given her COE (college of education) experience. Kroesch indicated that she will think about the proposition, but her being new to the UCC and new to ISU, she is still adjusting. Hurd asked Gawron (guest) to send out the IDS Minor Review for Children's Studies for the UCC members to review.

Hurd generally explained that the UCC will submit a one-page summary for the program coordinator for recommendations they should take. Newport asked a general question about proposal circulation. Gawron (guest) answered that courses are circulated, but it is a quirk in the system that courses are marked for UCC review. Gawron (guest) indicated that the UCC does not review courses but did highlight that the circulation process is for everyone to review the proposals as a matter of open governance. Paolucci asked about when AAC (Academic Affairs Committee) meets. Hurd indicated that they meet every other week.

### 8. ADJOURNMENT:

Carlson motioned to adjourn. Kroesch seconded. UCC adjourned approximately 3:50 pm.
