It was briefly explained that minor typo/editorial requests were made concerning some ambiguous phrasing. The minutes were approved.

## 4. Proposed Discussion and Action:

## a. Minor in Ethnic Studies (IDS) - Leonard, Jin

Leonard and Jin explained the program revision as primarily making changes to some of the electives and a reduction in total credit hours. Leonard/Jin indicated they looked into the list of electives and found several to be inactive. There was a discussion about the history of some of these courses, various technical aspects of decimalized courses and nondecimalized courses, and if the inactive courses will be removed from the list or kept. This discussion involved the 4 -andOut Report and how some courses can "fall off the books" due to inactivity. It was mentioned that the 4 -and-Out Report can potentially disproportionately affect humanities courses. This discussion primarily included: Leonard, Jin, Kalter, Lindsey (guest), Gawron (guest). This discussion moved to course offering frequency, how it might affect students, the differences between AMALI and Ethnic Studies, and histories of some courses/the Ethnic Studies program. Aspects of this discussion included French coursework/content areas, such as French studies versus Francophone studies. This discussion primarily included: Howell, Hunter, Kalter, Califf, Johnston, Ray (guest). Califf indicated that a vote to approve would be pending IDS 203 decimalizations and potential removal of two inactive GEO courses. Leonard motioned approval of the proposal pending these changes. Jin seconded. 13 voted in favor. 0 against. 1 abstention (Kalter). Below is the approved catalog copy:

Ethnic Studies is the study of race and ethnicity in U.S. and transnational contexts. Students and faculty in this area examine how social categories like race, indigeneity, culture, ethnicity, and nation are conceptualized. We also familiarize ourselves with the specific and comparative experiences (both historical and contemporary) of the major population groups that make up the United States and the globe. The program at Illinois State allows participants to examine regional, national, and global dimensions of these experiences.

Students interested in pursuing a major in this area may arrange their program of study through the Interdisciplinary Studies Major program.

Minors are also available in three specific areas: African-American Studies; Latin American and Latino/a Studies; and Native American Studies. A list of affiliated faculty and more information is available through the Ethnic Studies website.

## b. Anthropology Sequence and Accelerated Anthropology Sequence (ANT) - Leonard, Jin

Leonard and Jin explained the changes to this program and indicated that there is an accompanying accelerated program proposal making the exact same changes as the non-accelerated proposal. The lead reviewers indicated that the only changes being made were the removal of ANT 350 from the required list and moving it to the electives, while adding ANT 265 to the required list. The lead reviewers found a prerequisite issue with ANT 380, but Gawron (guest) indicated that this has been resolved with an editorial request. There was a brief discussion concerning library approval to add ANT 265, a new course, to the program, if the materials for the course are available, and if there were ethics content covered in the program given that there can be potential ethical concerns in anthropological work (such as working on skeletons). Miller (guest) and Hunter indicated that this course is an introductory-level course and that these materials are not specialized. Because of this, they felt the materials are/should be available. They also indicated that ethics is instilled in all/most of their courses, and that the program is NAGPRA compliant (Native American Graves Protection and Repatriation Act). This discussion included: Hunter, Miller (guest), Newport, Kalter. Jin motioned a vote to approve both of the proposals. Leonard seconded. 12 voted in favor. 0 against. 2 abstentions (Hunter, Kalter).

(*) A maximum of 12 of the total 15 hours of elective courses may be taken for graduate credit. Some 300-level courses are offered for undergraduate or graduate credit. Students in the Accelerated Sequence who want to count a 300-level course toward their 12 hours of required graduate coursework, must enroll in the 300 -level course for graduate credit at the beginning of the course in order for it to count.

To graduate in this sequence, a student must take at least one course for graduate credit during the senior year. The student must consult with an advisor and the instructor prior to the start of each new course to ensure approval.

The following anthropology courses may be taken by anthropology majors to fulfill General Education requirements but do not count towards electives for the major: ANT 143, ANT 176, ANT 197.

## c. Public Relations (COM) - Leonard, Jin

Leonard/Jin explained that the changes to this program were simple, in that they only added a new one-credit hour course (COM 181) to cover accreditation concerns in regard to ethics content. It was discussed on why an eight week one-credit hour course was sufficient to address the ethics accreditation concern and why the lecture contact hour was marked for " 1 " if the course is eight weeks. This discussion primarily involved: Kalter, Johnston, Califf, Myer, Leonard, Kroesch, Gawron (guest), Lindsey (guest). The overall conclusion comments were that the course appeared to have many different assignments and appeared thorough; that the one contact hour could be a deficiency in Curriculum Forms, but the form generally assumes a new course will be a semester long course, so some features of the forms might not match up exactly depending on the length of the course; and that offering formats are not regulated by the proposal system. This discussion also concluded that the rest of the program appears to instill ethics in their other courses (as indicated in the rationale of the proposal), perhaps this one-credit hour course is meant to patch a hole in the program, and to ultimately trust the accreditation process. Leonard motioned to approve this proposal. Jin seconded. All voted in favor. Zero against. Zero abstentions. Below is the approved catalog copy:

## 5. Liaison Assignments:

a. Council for General Education - Califf reported that CGE discussed the IDEAS requirement and the makeup of the group of individuals that will serve as content experts on such topics. Califf explained that volunteers were evaluated, that a diversity of faculty were considered from the different colleges, and that approximately six people were identified to serve on the committee. Kalter inquired about this as being a provisional selection until Academic Senate formally creates the IDEAS committee. Hurd/Califf confirmed this.
b. Council for Teacher Education - Kroesch reported that CTE discussed student teaching/clinicals compensation and how these students might be able to acquire clinical hours as substitute teachers, given various shortages.
c. Academic Affairs Committee - Kalter reported that Academic Affairs Committee did not meet last week, but they intend to discuss tuition waivers, the Pass/No Pass policy, and indicated a near-future agenda item will be concerning the Student Verification of Identity policy.

## 6. Staff Report:

Hurd indicated that they are moving forward with "demo'ing" new curriculum software to replace Curriculum Forms, the Academic Catalog, and potentially Course Finder. Hurd explained the general timeline will be about eighteen months before the start of implementation, but they plan to test out products and begin meetings on the subject in JanuaryFebruary. There was a brief discussion on this new software and the related systems that this new software might be able to replace. This discussion involved: Hunter, Califf, Lindsey (guest), Hurd.
