## Minutes \# 3

September 8, 2021

3. Approval of Minutes: Califf asked the UCC members if any changes/edits should be submitted. Kalter stated changes requested previously in the week and Gawron (guest) indicated that the changes/edits were made to the minutes. The corrected minutes were approved.

## 4. Proposed Discussion and Action:

## Therapeutic Recreation (KNR)

Carlson/Howell explained the changes as straightforward with the only change initially proposing making KNR 170 an option with KNR 175. Howell indicated that KNR 170 was for majors and KNR 175 was for non-majors. Howell explained further that various concerns were discovered upon reviewing the proposal but were largely resolved before the UCC meeting. Those concerns were: prerequisite issues with KNR 171, 176, 270 listing only KNR 170; KNR 378a30 listed as a prerequisite but not listed as required in the program; PSY 213 having PSY 110 as a prerequisite and PSY 110 not being listed in the program initially; and the Add Hours Form was not completed yet. Howell/Gawron (guest) further explained that many of these prerequisite concerns have already been resolved and that the only remaining concern with the proposal was the incomplete Add Hours Form. Hurd explained that KNR 175 is currently at CGE but would not hold up this program proposal given that KNR 175 already exists and is not a new course. Paolucci asked about discrepancies in the rationale referencing 55 hours when the program listed 73 hours. Mainieri (guest) indicated that this was just a typo. Kalter asked about potential readability issues with the catalog page and if additional wording would be needed to indicate how many specific courses are required in a program. After some discussion, Kalter indicated that it was a friendly suggestion. This discussion included - Gawron (guest) explained degree audit considerations of listing a specific number of courses to satisfy a requirement, versus minimum credit hours. Gawron (guest) also indicated that what displays in Curriculum Forms may be less clear than the catalog copy and highlighted that bold copy in Curriculum Forms has clearer formatting in the catalog. Gawron (guest) also explained that this would be inconsistent with the rest of the academic catalog and every program would most likely need this type of wording. This discussion included Hurd, Johnston, Hunter, Califf, Paolucci, Kalter, Newport. This discussion branched to general catalog improvements/clarity considerations. Hurd indicated she can look into it and investigate more on how students may be interacting with the catalog. Kroesch suggested a minor editorial change to move the options on the copy to be above the long list of NCRTC courses. Gawron (guest) indicated that this can be done by him and is a simple change. Hunter asked about NCTRC Support courses and what that meant, and if it should be specified in the copy. Mainieri (guest) explains the certification body and Hurd/Mainieri (guest) indicate that the copy does specify what this certification body is on the KNR page of the catalog. Hunter asked when these courses are determined to count for NCTRC or not. Mainieri (guest) indicated she was unaware of when these courses are evaluated, but the external certification body specifies these courses to the school. Pence asked if these concerns would prevent a vote on the proposal. Gawron (guest) explained that the only substantial pending aspect of the proposal is the Add Hours Form and indicated that a vote of approval, pending the Add Hours Form, could be appropriate given that, if the UCC revisited the proposal at a later date, it would be essentially identical, but just with the addition of the form. Kroesch moved to approve the proposal pending the Add Hours Form and minor editorial changes. Carlson seconded. Califf asked if there are any additional discussion points. Hunter asked if 73 credit hours for a program was normal. Califf/Ray indicated that it depends on the major and that double-dipping can occur to make a student's path to degree completion more efficient. Newport also highlighted certification considerations. Mainieri (guest) confirmed

Newport's assertion. Hurd/Ray also highlighted state compliance considerations (STAR). Gawron (guest) indicated that the course titles presented in the copy will be removed. Kalter asked why course titles are not included in the catalog. Gawron (guest) explained that there are multiple reasons for this, but the primary reason are the current technical limitations of the catalog and CourseFinder. Gawron (guest), Ray and Hurd indicated that integrating course titles into the catalog is currently being worked on and investigated. All voted in favor. 0 against. 0 abstentions. Below is the approved catalog copy:

Participation is required in a 6-credit hour (or greater) study abroad experience sponsored by Illinois State University or alternative international experience approved prior to participation by the minor advisor. Courses taken while studying abroad may be counted toward the minor. Contact the International Studies Advisor for information on which courses offered in each program may be counted toward the minor.
At least 9 hours of the minor must be at the 200-level or above.
Additional foreign language study is strongly encouraged. Special emphasis should be placed on developing oral communication skills.
A maximum of 9 hours (excluding courses in Category A) taken in the minor may also be applied toward the student's major.

## 5. Liaison Assignments:

a. Council for General Education - Califf indicated that CGE discussed course proposals, but nothing else needed to be reported.
b. Council for Teacher Education - Kroesch explained that CTE received word that they are a part of the Senate and must make changes to be Open Meetings Act compliant. New wording will be added to their bylaws to indicate this. Kroesch also indicated that CTE discussed CAPE, and a review through CTE will be needed by $\sim 2025$.
c. Academic Affairs Committee - Kalter indicated that AAC had met on August 25 solely to elect a chairperson and a secretary and was meeting for the second time this year later that evening (September 8). The posted agenda indicated that they would be reviewing their own functions for the benefit of new and continuing members, prioritizing their work for the year, appointing a member to the Academic Planning Committee, and looking at the annual reports from the external committees of the Senate that report up through it to the full Senate. They would also be reviewing and voting on a portion of the implementation plan for the IDEAS graduation requirement.

Gawron (guest) explained the future agendas and that the $9 / 22$ UCC meeting will most likely be canceled. Ray (guest) provided a friendly reminder that curriculum should be diversity, equity, and inclusion conscious. Ray (guest) indicated that advisors/other stakeholders mention that ISU's curriculum can be unfriendly to students who want to switch majors and there are significant economic and equity concerns for students when it comes to inflexible curriculum. This prompted a general discussion on best ways to improve and potential pain points of curriculum and the debates between flexibility and specialized knowledge/fields. This discussion included: Ray (guest), Califf, Paolucci, Kalter, Hurd.
