### Minutes #13

March 8, 2023

The minutes were approved without changes/objections

3. Action Items:

#### Data Science - Population Health (IDS)

Califf indicated that there was a bit of back and forth on whether HSC had resolved prerequisite concerns in the program proposal. Gawron (guest) explained that the prerequisite concerns appeared to be resolved via email, but formal proposals had not been submitted yet. Califf indicated that, since no formal proposals were submitted or approved yet, then a vote on Population Health would be delayed until the next meeting.

#### Molecular and Cellular Biology Sequence (BSC) (revision)

Pierce explained the changes as primarily consisting of: Removing BSC 204 option and requiring BSC 204; adding MAT 120 as an option with MAT 145; and changing electives. The primary concern the reviewers rose was that the “Take 15 credit hours” elective requirement had vague language concerning 200-level and 300-level Molecular & Cellular Biology elective courses. After some discussion, it was concluded that they should specify this list of courses being referenced, but otherwise the changes appeared in good order. There was also a brief discussion that the lab requirement needs to be better updated to indicate the labs more adequately. These discussions included: Califf, Howe, Pierce, Gawron (guest), Hunter. Howe motioned to approve the proposal pending editorial changes specify the elective courses and updating the lab requirement wording. Pierce seconded. All voted in favor. Zero against. Zero abstentions.

#### Career Specialty Sequence (ACC) (Deletion)

Pierce explained the program deletion proposal as straightforward. She was curious if the courses were also being deleted, but it was generally determined that the courses were separate from the program and are often offered independently of the program. There was a brief discussion of the history of this program and the rationale. This discussion included: Califf, Newport, Howe, Pierce. Pierce motioned to approve the program deletion. Howe seconded. All voted in favor. Zero against. Zero abstention. Below is the deleted program proposal copy:

Notes

Enrollment in 200-level business courses requires 45 completed semester hours. Enrollment in 300-level business courses requires 75 completed semester hours.

Family and Consumer Sciences Teacher Ed Sequence (FCS) (revision)

Pierce/Howe explained the changes as primarily being: FCS 300 changing to FCS 300a02; PSY 110 being added; and the total hours changing from 64 to 66. Gawron (guest) explained the add hours/PSY 110 change where PSY 215 (a required course) having PSY 110 as a prerequisites that needed to be listed/counted in the hours. Gawron (guest) indicated that an Add Hours Form was present/signed. Pierce motioned to approve the proposal. Howe seconded. All voted in favor. Below is the approved catalog copy/changes:

Council for Teacher Education – Kroesch indicated that ISU is dropping CAEP accreditation and will be searching for a new accrediting body. Kroesch explained the rationale as primarily being historical, in that CTE never voted on CAEP to be the accrediting body initially, that CAEP is changing some of their parameters in such a way that would conflict with ISU's education program directions/goals, and that CAEP is primarily geared toward smaller programs.

Gawron (guest) indicated that the Engineering proposals just arrived at the UCC status, but the exact timing of UCC review is a bit delayed given that some course proposals are still at the college.

There was a brief discussion on the Engineering faculty hiring timeline.
