## 4. Action Items:

# a. <u>Spanish Teacher Education Accelerated Sequence</u> (New Sequence)— Altenburger, Howe

Howe described this new proposal. An edit to language in an elective group was suggested. Edwards agreed with the suggestion and approved Sanchez to make this edit. Additional edits concerning numerical order of courses in lists, as well as how IDEAS is identified in the sample plan were discussed. Edwards approved Sanchez to make these edits as well. Henke and Altenburger asked questions about the proposal. Edwards explained and gave clarification.

Howe made a motion to approve this proposal with the approved minor edits. Altenburger seconded. All in favor, none opposed, none abstained. The motion passed.

# b. FCS General Sequence (Revise Program)—Jasper, Cheng

Jasper explained this revision, which involved removing one of the two existing options in the sequence. Cheng asked for clarification on the language and hours for the professional practice. There was additional discussion about the professional

practice and how those hours are listed. Altenburger gave some context about this major. The group decided to suggest no edits.

Altenburger made a motion to approve this proposal. Zhao seconded. All in favor, none opposed, none abstained. The motion passed.

They continue to encourage departments to hold proposals that are not critical. --The GE revision passed in senate. Implementation planning is starting. Courses will have to be handled first, and then departments will do revisions to majors and sequences. It is hoped these can be handled as editorial requests, but the scope is still unknown. Tentative timetable is to roll out the new GE in fall 2028.
