3. Action Items:

a. Legal Studies Minor (Program Revision): Thomas Burr and Thomas Howe

Discussion:

Adding LGS 313 as a minor required course Removing LGS 313 as a specialty course Adding LGS 210, LGS 311, LGS 315 and LGS 316 as Legal Studies specialty courses Howe asked the POL guests if a student could complete a POL major and Legal Studies minor. Yes, they can. The POL guests explained that the change to make the LGS 313 course a requirement instead of an elective is because of the American Bar Association (ABA) requirements. The program is an ABA approved program.

 <u>Political Science General Sequence</u> (Program Revision): Joshua Newport and Allison Kroesch <u>Accelerated Political Science Sequence</u> (Program Revision): Joshua Newport and Allison Kroesch Both program revisions are the same, replacing POL 296 with 196 so the proposals were discussed and voted on together.

Discussion:

The department explained that the change to a 100-level course allows students to take the course earlier in their college career. The department feels that the course will be more beneficial to them if taken earlier. **Howe:** question about the sample plan of study. Total only adds up to 117 credit hours for the general sequence. It was noted that some of the semesters have options for courses so the total hours are variable. The second semester of first year total hours needs to be corrected to read 13-14 credit hours. **Motion to approve both POL Gen and Accelerated Sequence proposals:** Kroesch

Discussion:

Summary of program changes: Replace THE 314a02 Acting Styles: Discovery and Performance: Shakespeare, with THE 314a03 Acting Styles: Discovery and Performance: On Camera Replace MUS 137 Applied Music (Voice) with THE 135 Applied Voice: Musical Theatre

Pierce: THE 241 has a prereq currently of MUS 137. That is the course they are removing. We reached out to the proposal initiators and they will submit an editorial request to change the prereq to THE 135, the course they are adding to the requirements. THE 329a05 has a prerequisite of THE 257 or equivalent. After discussions with the proposal initiators, they will submit an editorial request to change the prereq to "THE 257 or 2 credit hours of any DAN courses", this will allow the Musical Theatre students to satisfy the prerequisites without needing to obtain a permit to enroll in THE 329a05.
