This proposal is for a new Online Sequence for transfer students. The IDEAS requirement MGT 120 was noted as a winter session course in the sample plan of study and now it is planned for summer. There may be future discussions about offering the course during winter session. Students could have the option to take the course over winter session or in the summer.

The program will be geared toward working professionals and also traditional-aged transfer students. This business administration online sequence is being developed in part, to fill a need in the community now that Lincoln College has closed. Lincoln College offered a business program geared toward working professionals. This program is geared toward community college transfers; students can transfer in up to 70 credit hours from

a community college.

This revision is replacing TCH 209 Literacy II: Reading & Language Arts In The Elementary School with TCH 318 Study Of Bilingual/Bicultural Education. The Illinois State Board of Higher Education has mandated a change for programs that lead to licensure requiring coursework related to English Language Learners. TCH approves of the change.

Gardiner-Walsh asked for clarification about the developmental sequence of the new course TCH 318 (teaching strategies for ELL) and the other literacy courses in the curriculum, SED 342 and SED 358. Guest and proposal author, Ely, indicated that the SED 358 course for literacy in vision is less about how to teach literacy (such as 342 and 318) and more about how to use tactile methods in teaching those skills so SED 358 supplements and connects course, where the Deaf and Hard of Hearing Sequence have completely different methods and philosophies of teaching literacy.
