#### **4. Liaison Assignments:**

##### **a. Council on General Education**

Newport—CGE met recently and discussed several courses. Newport asked Hurd to give information they had presented to CGE.

Hurd—two items brought to CGE.

1) Demos for the new curriculum management system are scheduled in the next 2 weeks. There are three vendors showing us their products. We are not able to give a specific timetable on when a new system might be implemented.

2) The General Education revision process was discussed. It is close to going to CGE for approval to move on in the process. There are steps approvals beyond CGE, and then implementation, a process which could take as much as 4-5 years.

##### **b. Council for Teacher Education**

Kroesch—there are two legal issues that may/will impact TE at ISU.

1) Mental Health days for students. Still a lot of discussion at the state level. We do not know what it will look like by the time it gets to ISU to implement. This may include any combination of ISU setting dates, students taking at their own discretion, possible University blackout dates, etc.

2) Illinois Community Colleges offering baccalaureate degrees in areas with shortages, like nursing and teaching. This would impact TE at ISU for sure.
